Re: Scheduling: Codes and practices until further notice

External reports to state and federal government require the delineation of credit hours by the time of day or on-campus/off-campus locations. Additionally, internal analyses that allow us to manage workload can be improved with consistent coding of sections and courses. To ensure this information is reported accurately, we ask that all programs use the attached scheduling scheme. If prior schedules are rolled over, it will be the Department Chairperson's responsibility to verify that the section numbering is accurate for the type of section and includes time, day(s), and location where appropriate.

Internships, Externships, and Practicums with no on-campus component	All levels	400	Courses where students gain practical career-related experience; all off-campus activity	
Hybrid	All levels	H01 through H99	Courses that include online requirements, but where less than 100% of the instruction is online/asynchronous and may include requirements for students to attend on-campus face-to-face as described in the course syllabus	
MorganFlex	All levels	M01 through M99	Courses delivered where students have the option of being in the classroom at a specific time or joining online at that same time. Faculty are expected to teach in person. Students who are presented with the choice of modality at the start of the term can be held to that choice, if a syllabus detailing this has been given to the student before the drop/add period ends and the student acknowledges the requirements. Students may not be required to come to campus in person for any part of the course if they have selected the option to be online.	
Remote (online, synchronous)*	All levels	R01 through R99	Courses delivered online where students are expected to participate at specified times on indicated days using an online modality; time and days must be given in the schedule. Students cannot be required to come to campus. Instructors for this course and the courses must meet the same requirements as W sections.	
Fully online, asynchronous (formerly called "Web")*	All levels	W01 through W99	Courses that do not require students to attend at a particular time or day; material and requirements are posted fully online through the learning management system (currently Canvas); do not put time, day, or location	

^{*}Sections offered through this modality are only available for courses that have met the Quality Matters criteria (or any Morgan equivalent). Instructors teaching in these sections must have had the Quality Matters Teach on Line course (or any Morgan equivalent).

Independent Academic Work (IAW)	Undergraduate	A70 through A79	Courses where an instructor has agreed to meet with the student(s) to cover the content of an existing course where a student has a conflict regarding the
WOIK (IAW)	Graduate	A85 through A99	scheduled section or where the course has not been offered in the current term; time, day, and location must be provided in the schedule
Discussion (face-to-face)	Undergraduate	D01 through D99	Face-to-face discussion sections linked to large lecture sections
Discussion (remote)	Undergraduate	RD1 through RD9	Remote discussion sections linked to large lecture sections
